Seals rescued from ocean rubbish between 01 January and 31 December 2024, bringing the total number to over 4000 rescued individuals in 10 years.

OCN's seal rescue videos garnered over 1 billion views worldwide on social media in 2024, positioning our efforts as one of the leading global campaigns raising awareness about plastic pollution.

OCN organized community clean-ups with local schools, youth groups and volunteers, successfully removing over 12 tons of waste that could have polluted the oceans.



## Ocean Conservation Namibia's Plans for 2025

Continue seal rescue patrols to protect Cape Fur Seal from ocean rubbish.

Expand Coastal Clean-Ups to prevent rubbish from reaching the ocean.

Assist with African Penguin rehabilitation to protect the species from extinction.

Expand education programmes to reach 5,000 students in coastal regions.

Use OCN's social media power to promote worldwide conservation efforts, starting with the Dolphin Swim in Cambodia in March 2025.
